Open Discussions, last paragraph change “most of the Oxrem” to “all of the Oxrem”(Slauch, Freese) Carried

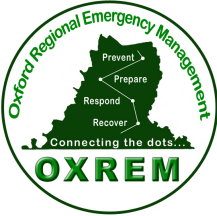
