- G. John S. discussed meeting with the new OASD superintendent. Hope to further discuss safety issues/preparedness in the district. Chrissie (from the County) waiting for a return call from Mr. Lewis.
- H. <u>Drill Committee:</u> Steve R. gave a report; everyone seemed to think it was good thing to do. Also agreed that it was shame that more of the community did not participate. Chuck F. would like to Chair and begin the Emergency Plan. John R. use check list as your guideline. Plan needs to be developed sooner rather than later. More discussion on this at the January 23rd, 2014 meeting.
- I. <u>PennDot</u>: Chuck F. informed all that he attended a PennDot meeting recently. Winter snowfall was topic. PennDot stated that we should expect approximately 24" of snow this winter.
- J. John S. attended a conference on Nixle. He was impressed with the information received at this conference. This system works even if phones & other types of radios are knocked off line. At present there are some 500 people in the Borough who are signed up to receive notification of emergencies. This is the largest notification system in the United States. Will get more information.
